NO. VIII.

As you are aware that DRAP Act, 2012 is a corporate organization under Ministry of National Regulation & Services. The services rendered by the office of the undersigned including Assistant Drugs Controllers and Federal Inspector of Drugs also envisage legal fee for processing your applications having commercial significance, which mainly include:-

- (i) Import of Finished Drugs.
- (ii) Import of Raw/Packing Materials (Clearance Certificate).
- (iii) Export Application (NOC for Export).
- (iv) Drug Import License (DIL) valid for 02 years for same source.

All the 04 main types of **commercial applications** fall under the rules and thus require processing fee under Head of Account No. 0010008463700018 with Allied Bank of Pakistan, Civic Centre, G-6, Islamabad for the disposal of your cases well in time.

Your kind cooperation for the implementation of the Statutory Rules and Orders must be complied with, in larger public interest so required.
