2. The Committee shall evaluate the applications for registration of medical devices and shall make recommendations to the Registration Board constituted under the Drugs Act, 1976 for registration, based on

quality, efficacy, safety and economic value of medical devices. Furthermore, it may give opinion on matters related to medical devices referred to it by the Federal Government, Central Licensing Board and Registration Board.

3. The Committee shall make procedures to regulate the conduct of its business.

4. In the absence of Chairman, the Vice-Chairman shall chair the meeting of the Committee.

5. The Chairman and members of the Committee are appointed for a period of three years, however, any member may at any time, resign his office or shall vacate his office if the Federal Government so desired.

6. This is an honorary appointment for which no remuneration shall be paid. TA/DA will be admissible only as per Federal Government rules for visits under-taken to attend the meeting of the Expert Committee on Drugs (Medical Devices).

7. The Deputy Drugs Controller (Medical Devices) shall act as the Secretary/Member of the Committee.

8. The committee may co-opt any person as a member who is expert of any specialty for the disposal of relevant cases.

9. The Convener himself or on the directions of the Authority, may call meeting of the Committee.
