Minutes of the Meeting

1. Recitation from the Holy Quran

The meeting commenced with the recitation of the Holy Quran, followed by prayers for the prosperity of the Association and the well-being of its members.

2. Confirmation of Previous Minutes

The minutes of the previous Central Executive Committee meeting were placed before the members. After due consideration, the minutes were unanimously confirmed without any amendment.

3. Approval of Election Schedule

The Central Executive Committee unanimously approved the **Election Schedule for the General Elections of the Pakistan Chemists & Druggists Association (PCDA) for the term 2026–2028** and authorized **Mr. M. Asim Jamil, Secretary General, PCDA**, to issue, publish, and display the approved Election Schedule in accordance with the Trade Organizations Act, 2013, the Trade Organizations Rules, 2013, and the Memorandum & Articles of Association of the Association.

4. Appointment of Election Commissioners

After detailed deliberations, the Central Executive Committee unanimously approved the appointment of the following Election Commissioners for conducting the General Elections of the Association:

- **Mr. Shahabuddin** – Chief Election Commissioner
- **Mr. Salman Ahmad** – Election Commissioner (North Region – Peshawar)
- **Mr. Syed Naeem Javed** – Election Commissioner (South Region – Karachi)

The Election Commissioners were directed to conduct the election process in a fair, transparent, impartial, and lawful manner in accordance with the Trade Organizations Act, 2013, the Trade Organizations Rules, 2013, and the Constitution of the Association.

5. Fund Raising Campaign

The Central Executive Committee unanimously authorized the **Secretary General** to initiate and coordinate a voluntary fund-raising campaign to meet the Association's administrative and miscellaneous expenses, and to place a report of the funds received and utilized before the Executive Committee for information and record.
